Historical Note

Catholic Urban Programs began as a department of the Diocese of Belleville in 1973 dedicated to programs serving the poor in East St. Louis. It includes the

Griffin Center, Neighborhood Law Office, and Holy Angels Shelter. In 2005, it merged with Hubbard House, a program to bring volunteers in to both live and work with impoverished communities in East St. Louis.

Scope and Contents

This collection contains materials related to the Daughters of Charity and their work with Catholic Urban Programs, particularly related to Griffin Center, a community program for those in public housing. It contains administrative documents and reports; correspondence; financial documents; brochures and newsletters related to the Diocese of Belleville and Griffin Center; copies of "Our World," a children's newsletter from the Griffin Center; newspaper clippings; photographs; and television and radio programs related to Griffin Center. This collection also contains information and photographs related to other houses and programs, including Roosevelt Center, Owens Center, and Deshields Center. It also contains information about the greater Diocese of Belleville, including directories and programs from their 100th anniversary celebration.

This collection contains seven series: 1) Administration; 2) History; 3) Correspondence; 4) Financial; 6) Publications; 7) News Items; 8) Audio-Visual.
