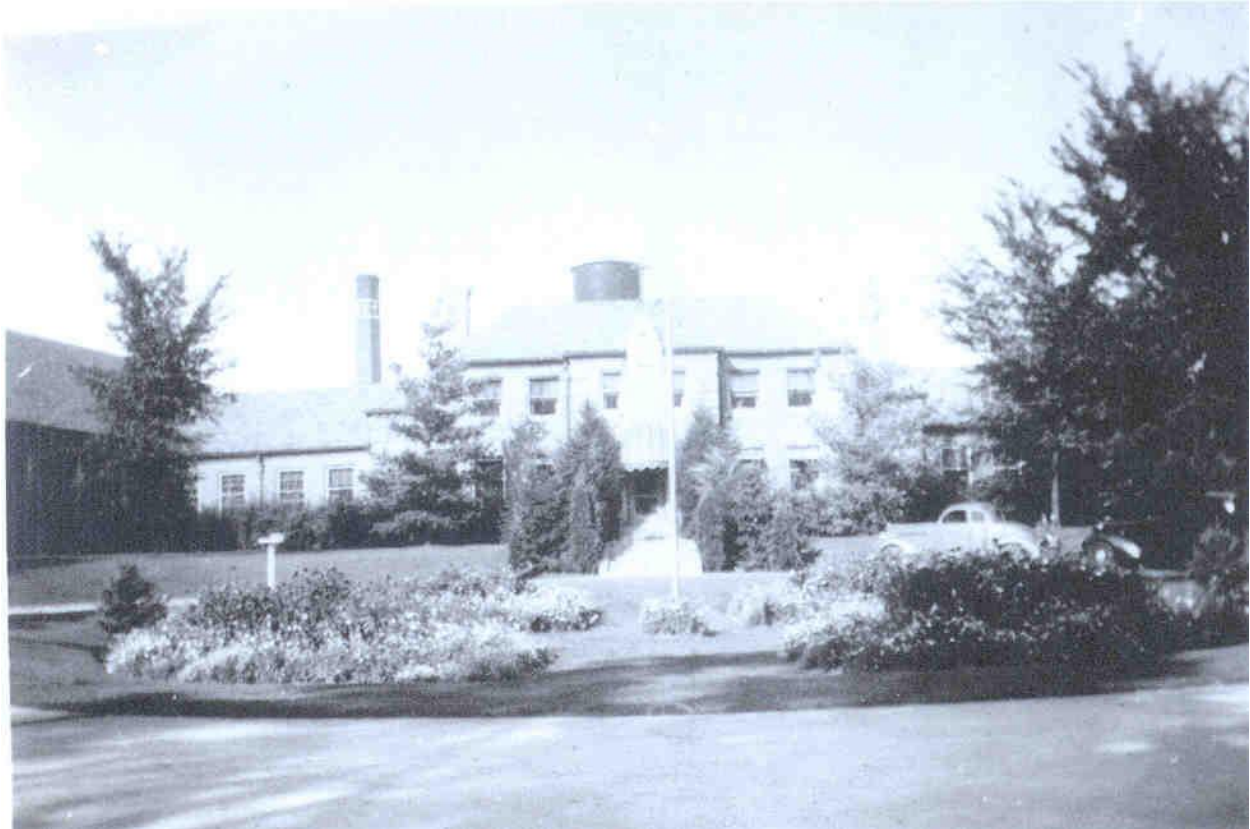

Historical Note

In 1928, Charles Fisher built a home for young children and named the home for his wife, Sarah. This home in Farmington Hills, Michigan acted as an orphan asylum for children up to 6 years old, before they went to either St. Vincent's Orphan Asylum in Detroit for girls or St. Francis Home for Boys after a fire destroyed the old summer home. This home was originally a summer home for the House of Providence, before it withdrew from that arrangement in 1951 when the orphanages owned and operated by the Daughters of Charity in the Archdiocese of Detroit re-aligned. St. Vincent's Home officially merged with Sarah Fisher Home and the name changed to St. Vincent and Sarah Fisher Home for Children. In 1979, Marillac Hall merged into St. Vincent and Sarah Fisher Home, although the name stayed the same. The purpose of the home was to provide care, health, and fresh air outside of the city for infant children. Its mission evolved from an orphan asylum to one providing child, family, and adoption services until 2005, when the center moved its offices back to Detroit in a non-residential capacity focusing on education. It has been run by a lay board since the Daughters' withdrawal in 2005.

Scope and Contents

This collection contains documents related to the ownership and operation of Sarah Fisher Home for Children and St. Vincent Sarah Fisher Center during the time that the Daughters of Charity operated the mission from 1928 to 2005. Due to the overlapping ownership and merger agreements, there may also be documents in the collection related to St. Vincent's Orphan Asylum, Marillac Hall, and House of Providence. The collection contains administrative documents, policies, and profiles; reports; fundraising and strategic plans; property documents; outreach work in Brighton, MI; documents from the Daughters local community; histories; correspondence; financial documents and reports; board of trustee minutes; wills and bequests; brochures and newsletters; newspaper clippings; photographs and slides; 50th, 60th, 100th, and 150th anniversary celebration materials; fundraising and community events; personnel lists; scrapbooks; videos; and documents related to the withdrawal of the Daughters sponsorship of the Center and its relocation back to Detroit.

This collection also contains documents related to the Seton pre-school which existed from 1972 to 1998.
