## Our Congratulations to Bishop Hannan!

E WHO are interested in the Cause of Mother Seton have much reason to rejoice in the honor conferred upon Bishop Hannan by His Holiness, Pope Pius XII. We express our heartiest congratulations upon his elevation to the Episcopate and upon his appointment as Chief Shepherd of the diocese of Scranton.

Bishop Hannan has rendered exceptional services to the Cause of Mother Seton. He has been canonical counselor to the Vice Postulator and has undertaken the arduous duties as Promoter of the Faith in two Apostolic Courts.

The post of Promoter of the Faith in the process of canonization is so important that the success of the tribunal rests upon his shoulders. Because of his official duty the Promoter of the

Faith must raise every obstacle against a Cause. By his position he is known as the Devil's Advocate.

His main object is to safeguard the interests of the Church. It is his sacred duty to see that nothing enters into the process that is not absolutely in accordance with truth and to see that everything moves along the line of strict adherence to the formalities and regulations laid down by the Sacred Congregation of Rites. It is important that the foundation is solid before the superstructure of the Process rises. Under his vigilant eye the tribunal builds the case so that a falsehood or collusion becomes absolutely impossible. Under his scrutiny even a pious exaggeration is removed from the factual evidence.

To attain these objectives, saying nothing of the technicalities of law which must be respected, it is evident that a Promoter of the Faith must be a man of exceptional ability. He must be not only an expert in canon

law and have a thorough knowledge of the Process but he must be also a skilled prosecutor in order to formulate questions and to arrive at the truth necessary for the success of the case.

We shall approach the subject by a simple narration of what happened when Bishop Hannan, then Father Hannan, professor of canon law at the Catholic University of America, took over the direction of the tribunal for the investigation of the alleged cure of Sister Gertrude Korzendorfer, a Sister of Charity, New Orleans, 1944.

When in 1945 the Vice Postulator was convinced of the extraordinary cure of Sister Gertrude (1935), having in his possession all the documents, he immediately set himself up as the worst critic and made sure that he would receive every possible

objection against the case.

He should anticipate any objections which can later be raised by the officials in Rome. With this in mind the Vice Postulator was guided by Dr. Valerio di Sant'Agnese, who was in the States at that time, and who was formerly the physician of the Italian Royal Family, professor of gynecology in the Roman University and medical expert of the Apostolic matrimonial courts.

Doctors in Philadelphia, St. Louis, New Orleand and Cincinnati studied the reports and submitted their opinions.

When the Vice Postulator was morally certain that any objections could be met, he petitioned Rome for an Apostolic Court to be set up in New Orleans for the canonical investigation. The request was granted.

His Eminence, Cardinal Salotti, the late Prefect of the Sacred Congregation of Rites, gave unprecedented privileges, which made another task for the Pro(Continued on Page 3)

### Mistaken Idea To Be Corrected

N SEVERAL occasions we have been surprised by the thought expressed, even by Sisters, that we must wait until Mother Seton is declared Venerable before we launch wholeheartedly into a Crusade of Prayer for miracles.

It is true that in the experience of the church, miracles generally occur after a Servant of God is declared Venerable.

Yet on these very pages we are narrating a cure of Sister Gertrude Korzendorfer, a cure that may be one of the requisite miracles, and yet this cure took place in 1935.

Miracles can happen any time and, if that be true, then NOW is the acceptable time to put forth all our efforts for these manifestations of Mother Seton's power of intercession before God.

Then why, it is asked, do miracles happen so often after the title of Venerable? The reason is that after Venerable, we put more faith in our prayers, more confidence in Mother Seton's power of intercession.

The fact is, if we were thoroughly convinced that Mother Seton is in heaven, we would put the same faith, the same confidence in our prayers to her NOW as we would after she is declared Venerable, after she is Beatified, after she is Canonized as a Saint by the Church.

The title of Venerable, the title of Blessed, the title of Saint will not make her one iota more powerful before the throne of God than she is today, than she was yesterday. These titles are her earthly glory; her heavenly glory is now what she was when she entered the eternal kingdom.

We just celebrated the Feast of All Saints. On the last day we shall find saints, maybe humble unknown individuals in life, who have a greater crown of glory in heaven than some of the canonized saints.

If you believe that Mother Seton is now in heaven, then NOW is the time to pray with full confidence that God may manifest her power of intercession by the performance of miracles!

moter of the Faith.

When the rescript letters, with all due formalities, were presented to His Excellency, Most Rev. Joseph Rummel, Archbishop of New Orleans, the Process of investigation began.

The Archbishop appointed the five judges and other members of the court and graciously granted the request that Father Hannan be the Sub-Promoter of the Faith, giving the title of the Promoter to the Officialis of the Archdiocese.

The process for a miracle of investigation rests on three important props, the Vice Postulator, the Promoter of the Faith and the Doctor Expert whose duty it is to attend the sessions to safeguard the interests of medical science. The Doctor Expert was the late Dr. Major Seelig, nationally-known cancer expert, Jewish by faith and an agnostic by conviction who did not believe in miracles. All these qualities made him a most desirable defender of science. The doctor was a charming character who gave his arduous services graciously and gratuitously.

The judges, five in number, perform a great duty. They must be of the highest dignity and competence. The chief judge of the New Orleans tribunal was His Excellency, Most Rev. Charles Greco, Bishop of Alexandria. With five keen minds focused upon the testimonies submitted to the court, it is evident that every detail necessary was extracted from each witness.

All questions must be submitted to the presiding judge who alone puts the question to the witness.

The notaries perform a herculean task. All questions and answers are written in long hand and corrections are made before the session is signed and formally closed. The notaries

must then make a transcript of everything for Rome. The original documents are kept in the archdiocesan archives.

In regard to the Vice Postulator! In the excellent thesis written by Rev. Damian J. Blaher, O.F.M., (The Ordinary Process in Causes of Beatification and Canonization), we read: "It has been rightly said that the duties of the Postulator are indeed serious and require much diligence, care, study and labor; it can be said and not without reason, that almost the entire direction of the investigations pertain to him. Therefore, he can spare no labor, study or pains in the fulfillment of his duties." In truth, then, the Vice Postulator in this case occupies a most important position. He is, under God, the prime mover of the whole undertaking.

With the magnificent cooperation of His Excellency, Archbishop Rummel, success crowned the heroic efforts of the court in the investigation of this alleged cure. The true success ultimately rests in the declaration of a miracle by His Holiness.

Since the Vice Postulator has studied the case thoroughly, interviewed the fourteen doctors on the case and gathered all the information necessary, he was able to present to Father Hannan very intimate knowledge of the whole cure with every detail possible. The Vice Postulator mentioned the doctors as witnesses to be called, what was to be expected from each in the line of testimony, their strong points and weak ones, and all this served as additional data for the Promoter of the Faith.

Here is seen the intimate link between the Vice Postulator and the Promoter of the Faith. At the beginning of the sessions the Promoter of the Faith and the Vice Postulator must part. The latter must remain on the outside, this for obvious reasons.

#### Synopsis of Case of Sister Gertrude

On January 5, 1935, Sister Gertrude Korzendorfer, a Daughter of Charity of the Western Province of the United States, submitted to surgery for cancer of the pancreas at the Hotel Dieu, New Orleans, La. The malignant growth was so far advanced as to be inoperable. After surgeons had removed a particle of tissue for biopsy, the abdomen was sutured. The case was one hundred per cent fatal.

Prayers were being offered by the orphans to God through Mother Seton's intercession for her cure. The Sisters of Charity in New Orleans began a novena of prayer.

The next day she felt neither pain nor nausea, relished food, and regained her strength and weight in a short

For seven and a half years she labored as administrator of De Paul Sanitarium, a large hospital for the insane, housing 250 beds. She never had a recurrence of her malady and died suddenly August 20, 1942, at Villa Saint Louise, Normandy, Mo., from pulmonary embolism, a pathological condition in no way related to her former affliction.

An autopsy showed no signs of cancer and disclosed no evidence of a scar in the pancreas where the tumor had been located.

every ounce of physical energy and required the utmost skill on the part of Father Hannan. He worked until the wee hours of the morning in preparation for the next session which usually began at ten in the morning and lasted until four or five and sometimes until seven o'clock in the evening.

At the conclusion of the tribunal twenty-five pounds of documents were signed and sealed with all formalities and forwarded to Rome. This is simply the first step of the long march of canonical procedure before the case reaches its final judgment, which is pronounced only by the Pope.

The tribunal was set up to gather all the material possible on the case so that the following three points could be proven beyond any shadow of a doubt:

1—THE NATURE OF THE DISEASE BEFORE THE CURE:

Proven by the testimonies of the doctors who operated upon Sister Gertrude. They found the cancer on the head of the pancreas so far advanced as to be inoperable.

The actual diagnosis of cancer is proven by the particles of tissue taken on the border line of the malignant growth and the unaffected part of the pancreas.

2—The Absolute Cure From the DISEASE:

Sister Gertrude died seven and onehalf years after the cure from pulmonary embolism.

A complete autopsy proved that the pancreas was entirely free from any signs of malignant growth. Slides showing the pancreas tissue prove the statements made in the autopsy report.

The formalities of the court are so rigorous, there are so many reasons for excommunications and invalidities, that except for expert handling on the part of the Promoter of the Faith, the members of the court could easily emerge from a session, striped like so many zebras with excommunications!

Father Hannan, having digested all the material in the documents and having reviewed the reports of the Vice Postulator, secretly formulated all the questions to be asked by the presiding judge of each witness. Other questions from the judges and Doctor Expert (which can be asked only through the Presiding Judge) developed with the testimony given.

This particular tribu-

nal, which ran about twenty days, demanded 3—That the Cure Was Effected Through the Inter-CESSION OF MOTHER SETON:

This is proven by the testimonies of the Sisters and orphans. Not only must it be proven that Mother Seton's intercession was invoked but it must be proven that no prayers were said to other saints.

After the close of the tribunal the Promoter of the Faith assured Father Burgio that he felt confident that the court had attained the above objectives. More than that he could not say.

The above sidelights give slight indication to the depth of gratitude due Bishop Hannan. May his efforts be blessed by the success of this case being one of the accepted miracles for Mother Seton's Beatification.

Again to Bishop Hannan, our prayers, our gratitude, our felicitations—AD MULTOS ANNOS!
