Historical Note

The Daughters of Charity accounts of the Civil War were initially collected by Provincial Director Rev. Francis Burlando, C.M. based upon the Daughters experiences in Emmitsburg, MD; Gettysburg, PA; Frederick, MD; Philadelphia, PA; St. Louis, MO; Donaldsonville, LA; Vicksburg, MS; Washington, DC; Richmond, VA; and Lynchburg, VA. The accounts contain information about battlefield nursing, movement of troops, Civil War hospitals, and major figures of the war between 1861 and 1865. Many of the Daughters, such as Sr. Gonzaga Grace and Sr. Matilda Coskery, were became known for their medical skills after the war as the Daughters nursed troops of both the Union and the Confederacy.

The Daughters served at nearly 60 sites in 15 states.

Scope and Contents

Correspondence of sisters in the war zones, hospitals, and provincial houses; collected Civil War Annals and accounts of the war, including the 1904 edited compendium of Sr. Loyola Law; lists of sisters; maps; photographs; records of Satterlee Military Hospital, Philadelphia, PA; memorabilia; secondary articles and programs

System of Arrangement

Collection was split geographically in provincial separation of 1910 and re-combined into semi-artificial collection loosely arranged by record type.

Conditions Governing Access

No access restrictions. It is requested that researchers use transcriptions or copies as much as possible. Some copies of material in other archival collections. Check inventory for provenance information. Permission for any type of publication of archival materials, including text, photographs, video, or audio

must be secured from the Daughters of Charity Communications Director before publication. Contact archives staff for appropriate forms and contact information.

Custodial History

Initially collected by Rev. Francis Burlando, C.M. and Sr. Loyola Law, D.C. before being transferred to archives. Split by geographic concern in 1910 provincial separation and re-created after provincial merger of 2011.

Additional information about Satterlee can be found at the National Archives and Records Administration (NARA) in Washington, DC. Satterlee records are part of Record Group 94 (Records of the Adjutant General's Office), Series "Field Hospital Records". These records consist of nearly 30 volumes, most of them fairly large. Some of the volumes are arranged chronologically by date of admittance, while others are arranged by a soldier's regiment and then by date he was admitted.

Another series containing data pertaining to a soldier's hospitalization is "Carded Medical Records, Civil War" These records are arranged by state, thereunder by the numerical designation of regiments, (i.e., all of a state's infantry, artillery, cavalry units under the same numerical designation would be filed together); and then by alphabetically by surname.
