Historical Note

In 1828, St. Louis Hospital was founded at the corner of 3rd and Spruce Streets at the petition of Bishop Joseph Rosati, first bishop of St. Louis, and John Mullanphy, a wealthy merchant and philanthropist, to the Sisters of Charity of St. Joseph. Mullanphy funded the first log cabin hospital and the overland transport of the first four sisters at the hospital. The log cabin hospital was in operation from 1828-1832 and was the first Catholic Hospital and the first hospital west of the Allegheny Mountains in the United States. When the Sisters of St. Joseph merged with the Daughters of Charity in 1850, they continued to operate the hospital. The hospital was expanded one block over at 4th and Spruce after a outbreak of Asiatic cholera in 1832 forced the need for expansion. In 1874, a larger hospital was constructed and renamed Mullanphy Hospital. The structure suffered sever damage during the 1927 tornado, and it was not repaired until 1930, when the hospital was renamed again to DePaul Hospital. In 1976, a new hospital moved to Bridgeton, Missouri in the outer suburbs of St. Louis. It was also a leader in the movement for hospital nursing schools, with DePaul School of Nursing opening in 1894 and operating until 1978. In 1995, the Daughters of Charity sold the hospital to the SSM Health Network, who continues to operate the hospital today as part of its system of Catholic non-profit health centers.

Scope and Contents

This collection contains primarily documents and records of DePaul Hospital from its founding in 1828 to its sale to SSM in 1995. It contains accreditation documents; administrative statements; organizational documents; reports; architectural documents and blueprints; planning documents; property sale, renovation, and purchasing documents; construction documents; operations of different departments and projects of the hospital; histories; accounts of the overland trip to found the hospital in 1828; accounts of the hospital; correspondence by administrators and by superiors with the Daughters of Charity; financial documents and reports; bylaws and articles of incorporation; board of trustee records; agreements and contracts with various medical. religious, and educational institutions for services, as well as vendors and suppliers; newsletters including "Upbeat" and "DePaul Quarterly"; brochures; directories; newspaper clippings; audio-visual materials; operational documents related to the DePaul Hospital School of Nursing, including reports, bulletins, handbooks, brochures, correspondence, newsletters, bylaws and articles of incorporation, reunions, and alumni; outreach projects for community health programs, including sickle cell anemia, alcoholic rehabilitation, and maternity services; anniversary programs; sisters' service agreements; and personnel and benefit programs. It also contains some records related to local communities of the Daughters of Charity more closely related to other missions in the St. Louis area, such as St. Anne's Home St. Blaise Residence, and St. Vincent's Hospital. This collection also contains secondary information on the Daughters brief operation of a Boys' Orphan Asylum at Vide-Poche, St. Louis, which was later taken over by the Sisters of St. Joseph of Carondelet. Some documents were created after the sale of the Hospital to SSM, particularly later-dated newspaper clippings, reunion programs, and anniversary celebrations.
